SUBJECT OF THE MEMORANDUM OF UNDERSTANDING

Cross Border Cooperation

The project "P.A.S.T4Future PLUS/No. ITALME-567 SMALL/CAPITALIZATION restricted procedure" (hereinafter "the project") is based on the Objectives of Interreg IPA CBC Italy – Albania – Montenegro Programme 2014/2020 as set out in the Operational Programme. The Programme aims to strengthen cross-border cooperation for smart and sustainable development of the territories involved, with a view to pre-accession of Albania and Montenegro to the European Union.

The Programme objectives are, in summary: enhance the framework conditions for the development of SME's cross-border market; boost attractiveness of natural and cultural assets to improve a smart and sustainable economic development; increase the cooperation of the key actors of the area for the delivery of innovative cultural and creative products; Increase cross-border cooperation strategies on water landscapes; Promoting innovative practices and tools to reduce carbon emission and to improve energy efficiency in public sector; increase coordination among relevant stakeholders to promote sustainable cross border connections in the cooperation area.

This Memorandum does not affect any other agreements on specific topics or initiatives that the parties intend to sign and does not in any way modify the possibility of the parties to define further commitments.

Any modification of the Agreement must therefore be shared and agreed upon by the Parties.

The changes must be made by written procedure and will enter into force once signed by all Parties.

Once they enter into force, the modifications become an integral part of this Memorandum of Understanding.






